RMBL may, in its absolute discretion, defer acting in accordance with the whole or any part of an e-mail/facsimile instruction pending further enquiry or verification of the instruction.

I/We agree to release and indemnify RMBL against all claims, losses, damages, costs and expenses howsoever arising as a consequence of, or in any way related to:

- a) RMBL having acted in accordance with the whole or any part of any e-mail/facsimile instruction,
- b) RMBL exercising its discretion to defer acting in accordance with an e-mail/facsimile instruction pending further enquiry or verification of the instruction,
- c) RMBL exercising its discretion to not act on an e-mail/facsimile instruction,
- d) RMBL repeating an action where an e-mail/facsimile instruction was received by RMBL more than once, except to the extent that RMBL has acted negligently in any circumstance in relation to any e-mail/facsimile instruction.
